No Vendor Parking Permitted in the Event Area.

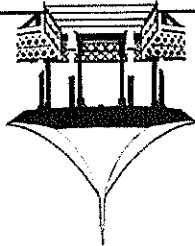

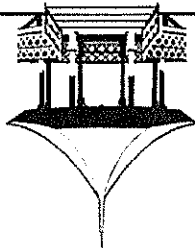
