ORDINANCE NO. 3-12

**Amendment to the Motor Vehicle and Traffic Ordinance
Located in Chapter 15, Part 4 of the Code of the Borough of Millersburg**

BE IT ENACTED AND ORDAINED by the Council members of Millersburg Borough, Dauphin County, Pennsylvania, as follows:

SECTION 1 – Purpose

The purpose of this Ordinance is to amend Chapter 15, Part 4 of the Motor Vehicle and Traffic Ordinance of Millersburg Borough. The enactment of this Amendment to the existing Ordinance has been determined by the Millersburg Borough Council to be for the benefit of the residents of Millersburg Borough.

SECTION 2 – Amendment

By this Amendment to the Ordinance, Millersburg Borough hereby establishes a reserved parking meter program for businesses located adjacent to metered parking within the Borough. By reserved parking, in the event a business is granted a lease under the reserved parking meter program, a parking sign will be permitted which would indicate that a parking meter spot would be reserved for the business or a patron of the business. This Ordinance is being included after the adoption of Resolution No. 12-08, updated by Resolution No. 12-13, which provided for a 90-day trial period by which Millersburg Borough Council assessed the benefits of a reserved parking meter program.

By this Ordinance, Millersburg Borough Council hereby ordains as follows:

1. Reserved parking under this Ordinance shall be in effect only during posted business hours of the business applicant.
2. The Borough Manager or other Borough employee authorized by Millersburg Borough Council shall create an application entitled “Borough of Millersburg Reserved Parking Sign Application” which shall be used by any business which would like to apply for a permit under this reserved parking meter program. By Resolution, Millersburg Borough Council may change the fees for issuing a permit and those fees shall be set forth on the reserved parking sign application. All

applications must be accompanied by an application or processing fee to be determined by Resolution. Initially, the fees under this Ordinance will be a \$10.00 application fee, a fee of \$50.00 to reserve a \$.25/hr metered slot, and \$25.00 for a \$.10/hour metered slot. Upon approval of an Application, Millersburg Borough will erect a sign with language on the sign set forth in the Reserved Parking Sign Application.

SECTION 3 – Repeal

All ordinances or resolutions or parts of ordinances or resolutions insofar as they are inconsistent herewith, be and the same are hereby repealed.

SECTION 4 – Effective Date

This Ordinance shall become effective October 10, 2012.
